### **CIGRE Australia AGM – Voting Process**

Whilst all votes cast are confidential, CIGRE statutes determine different voting weightings for different classes of membership. It is therefore necessary to be able to identify which member is voting so that the correct weighting can be applied to that member's vote.

Therefore, members will be required to complete the voting forms and where applicable the proxy form and either post, email or hand them to the Executive Manager/Company Secretary **PRIOR to the beginning of the AGM**.

This will allow the votes to be collated in the correct member groupings and the appropriate weighting to be allocated to each class of vote.

Following collection of any votes presented at the AGM, a count will be undertaken of proxy and votes lodged and the successful candidates announced during the AGM.

Results of the elections will be published on our CIGRE Australia website and nominated persons who are not at the AGM contacted with the result.

If you are a member representative of your organisation, please ensure that you have consulted within your organisation to ensure that the vote lodged reflects the view of the member organisation. NOTE: Each individual or collective member can only lodge *ONE* voting return.

The vote from a Collective member must be lodged by that organisations CIGRE representative.

Options for members in casting their vote are:
